# **MEETINGS AND DEADLINES**

**OCTOBER PROGRAM:** The subject for the October membership meeting will be Furs and Nuisance Wildlife. The presenter will be Doug Stanley. Participants from this summer's youth conservation camp will also be present at the meeting to share their camping experiences.

**RRGC HISTORY:** This is a repeat from last month. Howard Gardner and Russ Wyer are still compiling 73 years of the history of RRGC. They are transferring old documents into electronic data as a means for saving our legacy. Their continuing efforts are being published on the Club's website in the History Section. Given the amount of effort to copy and reproduce the historical data that the effort is taking a very long time. However, our social media is intended to relav current information to members and site visitors.

**CONSERVATION AND HABITAT:** Larry Martin provided the following information and photos of the guzzler work performed. 8-31 Greg Herrin and Larry Martin inspected and cleaned guzzlers 140, 141,142, 145, 146 and 154. These guzzlers are in Walla Walla county Dodd road area. Saw bobcat tracks at a guzzler. These guzzlers were put in next to habitat plots that RRGC helped put in many years ago. 13 man/hrs.

9-6 Jerry Bloom, Gene Van Liew and Larry Martin inspected and cleaned guzzlers 44, 45, 52 and 53. These guzzlers are located in Benton County south of Prosser off Lincoln, Farnum, Young and Burt James roads. Guzzler 53 has a broken apron frame board that will be replaced in the future. We had to walk into these guzzlers as much as a half mile. 21.5 man/hrs.

9-18 Larry Martin checked out guzzlers 125, 195 and 279 which were hit by wildfire a couple weeks ago south of Kennewick. 125 not damaged, 195 and 279 rain catching aprons damaged and need refurbish. Also inspected and cleaned guzzlers 126 and 127 which are in the general area but not hit by fire. 6 man/hrs.

9-19 Gene Van Liew and Larry Martin refurbished fire damaged guzzler 279 south of Kennewick, repaired the apron frame and installed all new metal posts to replace damaged wood posts. As we have seen before the posts catch fire first then burn the frame. Now with the metal posts we should see less damage from a wildfire. 15 man/hrs.

A reminder that if you come across a fresh road kill game animal and are able, please claim the animal and notify Chris Mosher. Please stay with the animal while waiting for someone from RRGC game recovery to show up. If the animal is seriously injured, inform the local police authority so that they or WDFW can dispatch the animal. A permit must be obtained from WDFW online within 24 hours. If the animal is left on the side of the road, it will be claimed by others and the Union Gospel Mission will not reap the benefit of a resource.

WOOD DUCK BOXES: Dale Schielke reported that he is still working on a new broadcast platform for the upcoming spring hatches. He also reported that a revision to his ALEA grant was requested and approved to purchase five geo-locating bands to put on wood duck hens next spring. The bands are made in England and cost \$126 each. Barker Ranch may purchase three more and Washington Waterfowl Association may purchase one or two. The bands have to be recovered to download the data showing where and when the birds traveled. It is hoped that because some of the hen wood ducks use the same nest boxes most years that the bands can be recovered before the approximate two year battery life expires.

#### **NEW BUSINESS:**

2. McNary Duck Conservation Day - Dale Schielke reported 36 kids plus parents and other adults attended the Duck Conservation Day at McNary NWR on September 8. Participation may have been low due to a concurrent event in Columbia Park called Riverfest and because there was no duck banding due to an avian botulism outbreak at the refuge. Dale, John Pfeiffer, Mark Kerns, Ron Ruth, John Merk and Mike Estes represented RRGC at the event.

3. Big game hunting seasons are starting up. Please keep in mind the need for game meat for the Wild Game Dinner to be held in March. We have storage facilities available so please consider donating fish, fowl or game.

4. From the Tri-City Herald there was a short article about Washington State WDFW perhaps buying parcels of land to improve and preserve habitat for the wildlife and wilderness areas. Information can be obtained from bit.ly/WAlandproposals. Comments can be submitted to lands@dfw.wa.gov by Nov 2<sup>nd</sup>.

5. President's 2018 Initiatives. Last month Mike brought up the subject of the appropriate level of RRGC involvement in proposed local and regional projects that could impact habitat for wildlife. This month Mike encouraged Board member awareness and involvement in public event and discussions pertaining to these issues. He read a short letter that Howard Gardner sent to Congressman Dan Newhouse pointing out that removal of dams on local rivers would require power generation alternatives that could have negative impacts on wildlife and wildlife habitat. Mike emphasized that we need to communicate with our elected officials and let them know when we support positions they are taking on issues like preservation of dams, returning management of wolves to state wildlife agencies, fighting against reintroduction of grizzly bears to Washington, and purchase of key properties to benefit wildlife.
