#### Big Game Farms - Howard Gardner

The board approved sending a letter to the State Game Commission supporting parts of their proposed regualtions on big game ranching. On January 15th the Commission approved permanent regulations prohibiting the importation of native deer, elk, moose and carribou into the state. The farming of fallow deer and reindeer will be allowed except for reindeer in Stevens, Ferry and Pend Oreille counties, and Spokane County north of the Spokane River. Regulations were approved that require the use of State Department of Agriculture disease testing standards for captive wildlife. Fencing standards were established for game farms. If you have an opinion on big game farms or commercialization of wildlife, please let the board know by writing to our president Mike Estes or Howard Gardner.

#### Umatilla Refuge Public Use Management Development Plan - Howard Gardner

This public use plan was reviewed and discussed by the board in our December meeting. After a great deal of discussion the board voted to suppport Alternative A of the plan which called for maintaining the present management approach. The other alternatives, b, c, and d, would have initiated increasingly more land and water closure to hunting and fishing. We did not believe the data was present to support any of the proposed closures. In addition, in our correspondence communicating our position on the plan, we reiterated our position of opposing guided waterfowl hunts on the refuge.

#### Proposal to Eliminate the Wildlife Commission.

As you probably already know from recent newspaper articles, mailings from the NRA, and from other articles in this newsletter, there are numerous proposed bills before the Washington House and Senate which affect hunting, wildlife, and your right to keep and bear arms. As of this week, there are at least 30 proposed bills on these topics in the State legislature. The RR&GC Board is doing its best to stay current on the status of these bills and to make appropriate input to our local legislators, to legislative committee members, and to the governor's office. It is also important for you, as an individual, to call and write letters on these topics.

One piece of legislation that is currently being drafted is a proposal to combine the Department of Fisheries and the Department of Wildlife. Speculation is that the bill will be introduced by Senator Brad Owen, chairman of the Natural Resources Committee, on behalf of the governor's office during the week of February 23. Part of that proposal will apparently eliminate the Wildlife Commission. The Commission is composed of persons who are NOT employees of the State, who set hunting and fishing seasons and bag limits. If the Commission is abolished, who will assume their duties and responsibilities? Would you be concerned if department employees (i.e. Curt Smitch or his equivalent) would make these important decisions within the bureaucracy of state government without the opportunity for public input? A copy of the proposed bill has been requested from Senator Owen's office and will be discussed by the Board for possible action when received.

#### Wildlife Areas Scoping Meeting - Howard Gardner

Because of changes in patterns of wildlife use, habitat, public use and recreational activities on Department of Wildlife (DOW) managed Wildlife Areas, the DOW is holding scoping meetings around the state to obtain public comment. I represented the club at the meeting held in Pasco on January 23, 1993, and as identified by the Board, made the following recommendations:

- Manage Wildlife Areas to maximize public hunting, fishing and trapping opportunities.
- . Maintain or maximize the wild or primitive character of the land. Other than campgrounds, outhouses and boat ramps at points of entry, there should be no other activity/development.
- . Stress walk-in recreation, minimize roads.
- Prohibit waterfowl guiding.

#### SB 5160

### GUN RIGHTS and YOUR ABILITY TO HUNT ARE UNDER ATTACK IN THE STATE LEGISLATURE

The anti-gun/anti-hunting legislators in Olympia are in the process of pushing Senate Bill 5160 through to become law in the State of Washington. If this bill becomes law, we will experience serious restrictions to our Second Amendment rights and our ability hunt. It is another attempt to punish the law-abiding gun owner for what the criminals are doing in our society today. These new laws will have absolutely no affect on the criminal and increase the chances of making a criminal out of today's law abiding gun owners.

Examples of the proposed legislation which may hit home with you are:

A 5-day waiting period on all sales of semi-automatic rifles and shotguns. This would include the Remington 1100, a standard hunting shotgun. Effect on the criminal - None. They will still buy their illegal guns on the black market, no registration or waiting period.

Result - Law-abiding gun owners pay the price! Solution - Enforcement of current laws on the books.

A special license would be required for every semi-automatic firearm owner just to transport that weapon from his/her home. Effect on the criminal - None. They won't buy a special license for their illegal guns, but they will still transport them at will. Result - Law-abiding gun owners pay the price. Solution - Enforcement of current laws on the books.

In addition, SB 5160 contains language aimed at restricting various aspects of gun ownership. One of these mandates that firearms kept in the home be stored in certain ways. Among the recommended procedures under the so-called "safe storage" provision is for loaded firearms to be stored with either a trigger-or gun-locking device. Gun owners know that such a practice is dangerous and can lead to accidental discharge. Firearm and trigger-lock manufacturers specifically warn against storing firearms in such a manner.

Ask your legislators why they think singling out gun owners for prosecution will improve the safety of Washington's children. laws are currently on the books making it a crime to recklessly endanger a minor. The fact is more kids die in Washington from bicycle accidents than from firearm accidents!

Another key section of SB 5160 dismisses the effectiveness of current law. This bill would enact needlessly restrictive laws concerning the possession of firearms on school grounds. Remind your legislators that it is already illegal for a minor to possess a firearm anywhere without adult supervision—including in school. And, remember it is also unlawful to carry a firearm concealed without a permit. Proposals such as this could be utilized to threaten law-abiding parents when picking up a child from school.

Don't allow yourself and your Second Amendment rights to be used as an excuse! Make your elected leaders muster the courage to declare a real war on crime and criminals and tell them to leave law-abiding citizens alone!

To complicate matters, Governor Lowry is proposing to re-write the sentencing guidelines for the State of Washington. His intent is to reduce the Department of Correction's budget - 35 million dollars - giving lighter sentences to convicted criminals walking the streets committing more crimes which will in turn increase pressure to outlaw our guns.

It is time to stand up and let our legislators know that we ARE NOT WILLING to put up with their ineffective ways of dealing with these issues. Meaningless gun control does not translate in meaningful crime control! The rights of Washington's honest gun owners and sportsmen must not be sacrificed in a vain attempt to control crime in the State.




#### Wood Duck Boxes - Dale Schielke







#### APRIL GENERAL MEETING REPORT

Fishing! Fish! Fishing! Catching! Fish! It is that time of the year, fishing season is open and family fishing weekend is coming up soon! Art Viola, Joe Foster and Eric Anderson, Department of Wildlife biologists were special guests, treating us to an overview of the fishing prospects for 1993! Here are just a few tips on fishing Eastern Washington's lakes and rivers (besure to read the Fish and Game regulations for specifics regarding the seasons and possible restrictions):

- ..Tucannon River..Opens June 1st. 10,000 Rainbows will be planted. Get there before the end of June for the best fishing!!
- .. Touchet River.. Opens June 1st. Planted with 5,000 rainbows and 11,000 Brown Trout! Try the confluence of the north and south forks. Those Browns are hard to catch!
- ..Tucannon Lakes..Open March 1st except Curl Lake which opens June 1st. 115,000 fish will be planted in these lakes. Curl Lake is a handicapped access lake and has good steady fishing all summer.
- ..Mill Creek Reservoir..Will be planted four times with 31,000 fish. Will be good early fishing.
- ..Bumping Reservoir..Good fishing year around, especially through May. Try maggots. Good for 6 to 9" Rainbows.

- ..Wild trout fishing is good in the Tieton, American, Naches, Little Naches and Bumping Rivers.
- ..Wenas Lake..Good for Brown Trout up to 8 pounds, Try evening fishing with night crawlers on the bottom, down near the dam.
- .. Kachess Lake.. Good lake for Kokaneee through early June.
- .. Sprague lake.. Fantastic late in the evening fly fishing on the shore line.
- ..Warden Lake..Will be real good for 12 to 14" Rainbows!

#### MARCH 1993 GENERAL MEMBERSHIP MEETING


This month's general meeting will be held in the Franklin County PUD Auditorium, 1411 West Clark, Pasco, same time, 7:30 pm.

So far about 23,000 acres have been purchased. 3) Game Farm Alternative - The original plan was to plant 20,000 Pheasants every year for 20 years. Then the attitude about planting pheasants changed in the Department and the money being spent to raise pheasants was paid to the farmers to compensazate for leaving habitat and cover for wildlife. This is one of the largest mitigation projects undertaken so far. Join us and hear what Rocky has to say.

#### May Board Meeting - Mike Estes, President

Special guests at the May Board Meeting were Ray Duff and Larry Popejoy, regional manage of the Department of Wildlife, who were in town Tuesday to meet with instructors and department personnel about hunter education training in the Tri-Cities. Larry and Ray spent more than an hour briefing us on the merger of the Departments of fisheries and Wildlife, changes to the Wildlife Commission and its expanded role, and current and future DOW projects. Both managers expressed appreciation for the active role the RR&GC has taken on wildlife issues and the Board pledged to continue that involvement in the future.

#### Poachers Beware!

The Washington State Legislature has taken a tougher stand against poachers. A bill introduced and signed this week allows Washington to join the Wildlife Violator compact so Washington wildlife agents can work with other states to solve poaching cases. Under the new law, out-of-state violators cited in Washington will no longer be able to return to their native states and ignore the citation as their home state will revoke their hunting and fishing privileges until the Washington citation is resolved.

In return, Washington will revoke the hunting and fishing privileges of a resident who refuses to pay the fine for a violation committed in another state.

Revocation of hunting and fishing privileges by any state means loss of those privileges in all states.

#### MAY GENERAL MEETING REPORT

Rocky Ross gave a wonderful presentation on the Lower Snake River Compensation Plan!! This effort, under taken by the Walla Walla District of the U. S. Corps of Engineers and the Washington Department of Wildlife is the largest fish and wildlife mitigation project undertaken. This project, designed to replace the habitat lost on the Snake River when Little Goose, Lower Granite, Monumental and Ice Harbor dams went in, has been approached with four goals:

- 1) On-project development, which includes efforts such as vegetation planting, Goose nest structures, guzzzlers, and fencing to keep out cattle.
- 2) Land acquisition, with an original goal of 8400 acres for fishing access and hunting. To date, 1500 acres of Chuckar hunting access lands and 700 acres of fishing access lands have been procured.
- 3) Interim compensation program, developed to support projects where fast results will be seen, as it takes 20 years for lost habitat to be replaced. Includes items such as raise and release programs for pheasants, and cooperation agreements with private land owners to plant habitat and allow public hunting.
- 4) Resident trout program, which includes in-stream habitat improvements for natural trout production.

Included in this newsletter you will find a listing of all the public hunting and fishing access points/lands of the lower Snake River.

Upper Yakima River Species Interactions Studies. The guest speaker for our June 1st General Meeting, being held at the Richland Public Library, will be Geoff McMichael, Department of Wildlife, Fish Biologist. Geoff will give a special presentation of the Upper Yakima River Species Interactions Studies. These studies have been going on for the past three and one half years. The project has two main objectives. They are 1) to collect baseline information on resident trout population in the Yakima River above Roza Dam (population estimates, movement, growth, spawning locations, etc...) and 2) to conduct experiments to investigate the competitive interactions between wild resident trout and hatchery steelhead smolts.

This last winter there was a news segment on one of our local TV channels showing the game department putting radio transmitters into trout so they could track their movements. This is where the idea came from for our special presentation. It sounds interesting to me! Hope to see you there!






#### Annual Club Summer Picnic

#### Patty Murray's Gun Control Tax

As you have probably heard, Patty Murray, a Washington freshman senator has proposed a 25% sales tax on certain weapons and ammunition. The money raised from this tax will fund victims of accidental or deliberate gunshot wounds. In addition, she wants to raise the 3-year cost of a federal firearms license from \$30.00 to \$2,500.

It is important that you let Patty and other legislators know how you feel about her proposal.



#### Fish Counts - Dave Myers

Salmon and Steelhead fishermen: You have probably watched with interest the daily counts of fish passing over the Columbia and Snake River Dams. The accompanying graphs provide the compiled data for those passing over McNary Dam. The first graph shows the daily counts. The second shows the approximate number of salmon in the reach between McNary, Ice Harbor and Priest Rapids Dams. It looks like it is going to be a good spring chinook fishery on Icicle Creek near Wenatchee as over 25,000 fish have passed over Priest Rapids Dam.

I will try to keep these graphs updated as long as the Tri-City Herald keeps printing the counts (about November). It would be most interesting to correlate fish catches vs fish counts, river discharge, temperature, etc. If you are interested in helping please provide me with data concerning fish caught, including the date. #### JUNE GENERAL MEETING REPORT

Geoff McMichael, Department of Wildlife Fish Biologist, gave a wonderful presentation on the Upper Yakima River Species Interactions Studies. The objectives of the studies are to obtain data on the resident trout population, conduct short term experiments that will provide information on the issue of competition between resident trout and anadromous fish, and to develop long term monitoring plans. Geoff reminded us of an important fact: In catch and release situations, 30% of the fish caught will die if they are handled while being released. If release is done without handling the fish, 90% will survive. Use wet hands if you have to handle a fish or a soft nylon landing net. If you have to handle the fish, hold it upside down under water barely cradling it and it will settle down. That's it on hints! We learned other hints, but you will just have to begin coming to the meetings to learn them!

One more item though.... If you catch a radio tagged fish in the Yakima River catch and release area, or from a tributary, please be sure to record it on the form reprinted below and mail to the Washington Department of Wildlife.

#### Benton County Critical Areas Protection Ordinances - Howard Gardner

The purpose of this ordinance is to meet the requirements of the Washington State Growth Management Act. The protected "critical areas" include: wetlands, frequently flooded areas, fish and wildlife habitat conservation areas, critical aquifer recharge acres, and geologically hazardous areas. After reviewing the ordinance and discussion with Mike Estes, Jack Pickard, and Jerry Zeitler, the following comment was given at a public hearing before the Benton County Planning commission:

- .. Opposed low intensity agriculture, such as livestock grazing, as an allowable use in critical resource and riparian buffer areas. This was based on the disruption to wildlife use.
- .. Within a critical area or buffer we opposed the removal, excavation, stockpiling or grading of soil in any amount. Same reason as given above.
- .. For new surface water discharged to a river or creek, in addition to no decrease in water quality, the club requested the impact of a fluctuating water level be part of the performance standard.

#### Columbia River Salmon and Steelhead - Dave Myers

As predicted at our last club meeting, the steelhead returns this year are dismall at best. September, 1993, counts are at less than 20% of September, 1992. Salmon counts are about 20% above last year, but do not appear to be being caught at even last year's level. You will have to work hard to put a fish in the cooler. It looks as if the peak has not reached McNary Dam yet, but may get here before the end of September. Rumor has it that fish are being caught near the mouth of the Deschutes River below Biggs Junction. Fishing pressure on the Hanford Reach has been abnormally light, with few reports of fish being taken. I did, however, hear of a 48 pounder being taken September 21st!! #### Landowner Relations - Hunter Ethics



In order to claim this refund you must keep records of that fuel used exclusively for marine purposes. If you have such records as required, you may initially claim a refund for the previous 13 month period. If you are interested write to:

#### Congratulations on a Job Well Done!!! - Mike Estes, President

With the end of the year quickly approaching, this is an appropriate time to pause and reflect on all that we have done as a club during 1993. Volunteers from our club have donated thousands of hours on a multitude of projects that will benefit wildlife and enhance our opportunities as sportsmen for years to come. We participated in habitat projects in Benton, Franklin, and Walla Walla counties. We donated thousands of dollars for worthwhile projects like the Upland Wildlife Restoration Project, Rattlesnake Mountain Shooting Range, Central Washington Warmwater Fisheries hatchery, and a deer decoy for the Department of Wildlife. Funding for our donations was available primarily due to the efforts of everyone who worked at the Salmon Booth at the Allied Arts Sidewalk Show in July.

The Board of Directors have communicated frequently with local state and federal agencies (Corps of Engineers, Fish and Wildlife, BLM, U.S. Forest Service and others) on numerous issues. We have talked with and written to state legislators, Congressmen, and Senators about proposed legislation affecting hunting, firearms control, wildlife and the environment, and the Fitzner-Eberhardt Arid Lands Reserve. Our efforts have been recognized and rewarded, and our input has made a difference.

It has been an honor for me to serve as your president this year. The efforts of the officers, trustees, and volunteers working together has enabled us to accomplish more than I could have imagined. Thank you very much for all that you have done to contribute to our success.

#### RR&GC Buys All-Terrain Vehicle - Dale Schielkie

In February of this year, the RR&GC applied for funding for a cooperative wildlife project. The "co-op program" provides funds to volunteer organizations who perform approved wildlife enhancement projects. Equipment purchased to perform these projects becomes the property fo the Department of Wildlife. Funding to perform co-op projects comes from the Department of Natural Resources (DNR) Aquatic Lands Enhancement Account. Proposed projects are submitted for evaluation and rating by an Executive Management Team. Approved applications are developed into contracts with the volunteer organization.

In September, our \$7500 proposed project of purchasing an all-terrain vehicle (ATV) for guzzler inspection and maintenance was approved. The ATV will assist both habitat specialists and club volunteers carry tools and repair materials to the remote guzzler sites.

During this past month the Department of Wildlife took possession of a 1994 Yamaha ATV with winch, brush hog mower accessory and loading ramp. This completes the co-op purchase.

The ATV will be used in the early spring by the RR&GC volunteers and specialists in accessing the remote guzzlers for the annual clean-out and maintenance of the 50+ guzzlers located in Benton County. If you would like to help with this project, watch for signup requests for volunteers at our general meetings and bulletins early in 94.

The December meeting of the Environmental Information Network will be on "Nitrate Pollution of Groundwater in the Columbia Basin." If you are interested, the meeting will be held in the Main Gallery of the Pasco Public Library at 7:00 p.m. on Thursday, December 16th. Guest speakers will address the origin and possible health effects of the nitrate pollution.


To date, TCSA has been approved for three development phases under the Firearms

Range Program of the Washington Interagency Committee for Outdoor Recreation. Phase I consists of the practical pistol ranges and a 200 yard multi-purpose range with covered firing points. Phase II will develop a 1000 yard high power rifle range, trap and skeet fields, and a 10 station sporting clays course. These phases include development of associated access roads and parking lots. Phase III will provide for a well and a water and electrical distribution system.

Each phase has been approved for \$50,000 in state money, but these funds must be matched with goods and services purchased by or donated to the TCSA. Since the cost of materials will consume a major portion of the community to donate labor, construction equipment time, materials, and cash to help turn to must make this dream a reality.
