ATTENTION HUNTERS!!: The hunting season has started and once again it is time to set aside some of your harvest for the Club's annual Wild Game Dinner that will be held in March of 2008. Donations of game meat including waterfowl, other unique game meat such as bear, boar, or cougar; upland birds and clean, boneless big game roasts. Halibut, steelhead and salmon are also needed. Donations thus far have been very slim, please get them in as soon as possible. A good big game roast is the sirloin tip. It is boneless, relatively tender but dry, therefore it should be cooked with moisture in a closed pan. Every hunter, whether he cuts his own meat or not, can remove this roast as follows: (the diagram is shown on the Club's web page under 'Club News-Newsletter' and click on 'Other Club News'). After skinning and while the animal is hanging, place your knife just below the animal's kneecap. Cut into the leg until you reach the leg bone, turn your knife and follow the leg bone until you reach the rump knuckle, then turn the knife 45° and cut out. Another good boneless roast is the round roast which can be cut in about the same manner. It is located just above the sirloin tip roast. Clean the meat or fish thoroughly, pat it dry and double wrap it; first with plastic wrap and then with waxed freezer paper. Be sure to squeeze all the air out around the meat (NO GROUND MEAT PLEASE). Seal with tape and mark package as to what it contains and with your name and hunting license number. Bring the package(s) to the General or Board Meetings. The packages will be placed in an ice chest(s) and then stored in a freezer. Your donations will help make the Wild Game Dinner a big success. Good hunting and good fishing!

- The first meeting of the New Year will be 7:00 P.M. Tuesday, January 8 at the **Battelle Auditorium in Richland** instead of the Richland Maintenance Facility. A map showing the location of the auditorium is at:

To access the auditorium, drive north on George Washington Way, turn left at Battelle Blvd. and then turn right at Q Ave. and the auditorium is on your left behind the Research Operations Bldg. (ROB).
- The Tip of The Month will be by Don Hunter who will relate his experiences after he fell out of his boat into the Columbia River this December.
- The main topic will be "Predator Calling & Fur Handling" by Club members Howard Gardner and Larry Martin.
- BRING A PROSPECTIVE NEW MEMBER TO THE MEETING AND RECEIVE FIVE FREE RAFFLE TICKETS.
- March 29 Wild Game Dinner tickets for \$15.00 each will be on sale at the meeting. The price is unchanged from last year.
- Bring game and fish donations for the Wild Game Dinner to the General and Board Meetings, the meat will be placed in an ice chest(s) and transported to a freezer for storage.
- **<u>DECEMBER GENERAL MEETING REPORT</u>**: The last meeting of the year meeting was opened by Club President Dale Landon. The meeting room was full. There were many, many visitors in attendance.
- Dale Landon stated that Marilyn Steele was the winner in the Club's Salmon Derby. She entered two salmon, the only fish entered, and won a total of \$70.00; the entry fees from both the 2006 and 2007 Derby.
- The mini-presentation of the month was given by ten year old Cody Carr, his 10th birthday was on December 4-the same date as the meeting. Cody was one of the two youth that participated in the Barker Ranch Youth Day Duck Hunts held on November 10. Mason Nelson, the second youth, was not able to attend the meeting. Cody hunted with his father, Sean, and guide Dean. He described his successful hunt, the after the hunt barbecue luncheon, all the training sessions he attended and the gifts he received from the Barker Ranch including a custom hand made duck call. He was thrilled with the event and

thanked Michael Crowder and the Barker Ranch that made it possible for him to participate.

- After Cody's presentation, voting for 2008 Club officers and trustees was held, results are shown in this Newsletter. Several announcements were made after the election by Rick Nelson, Lyle Gilk and Richard Sharp.
- Gary Loomis the main speaker of the evening was introduced by Stan Brogdon, local member of the Coastal Conservation Association (CCA). Gary was the founder of GLoomis Rods. He started the Fish First organization (http://fishfirst.org/) located in Oregon. Gary is very active in the CCA (http://www.joincca.org), he is the Chairman of CCA-PNW which now has chapters in Oregon and Washington (www.ccapnw.org). CCA-PNW is an advocacy group for salmon, steelhead, and other Northwest fish. Its goal is to give voice to this precious resource that cannot defend itself against destruction.

Gary started off his presentation by describing the FFA organization which started in 1995 in Oregon and whose goal is 'more and better fishing and NO politics'. He described and showed some of their successes in Oregon such as: a) the introduction of net pens located in streams where hatchery fry are placed in the pen and allowed to grow to smolt size and then released into the stream, b) egg boxes with fish eggs are placed in streams where the eggs are hatched at 98% yield and the fry are able to swim from the egg box into the stream, since there usually are not sufficient nutrients in the stream for the fry to thrive; spawned out fish carcasses are placed in the stream to provide nutrients for the fry, these nutrients are available for fish 3-4 years after the carcasses are placed in the stream, c) removal and replacement of culverts that block access of fish to streams upstream from the culverts and d) habitat restoration to allow the formation of correct ripples to pond ratios in streams.

- Commercial fishing and non-selective harvesting of salmon are the major reasons that salmon numbers are declining. Eighty five percent of the salmon that should be returning to Washington and Oregon are harvested in Alaska. After salmon gill netting in Washington and Oregon, there are a few fish left for sport fishing and spawning.
- After the collapse of the Atlantic salmon in 1864 due to harvesting for canneries, 36 canneries were relocated to the Pacific coast. From 1871 to 1883, 1 to 3 million salmon per year were harvested and canned. The salmon runs collapsed in 1884 and inferior fish were harvested for the canneries. At that time 12 hatcheries were built to produce salmon for the canneries. In 1938 the first Columbia River dam, Bonneville, was put into operation. It and other dams on the Columbia and Snake Rivers are being blamed for the decline in salmon. The salmon had collapsed more than 50 years earlier and the dams and lack of habitat are now being blamed for the decrease in salmon and steelhead.
- The CCA, with more than 90,000 members, is the largest of three advocacy groups in the United States. It has been very successful in turning around the decrease in Redfish and Striped Bass numbers in the Gulf and Atlantic coast by lobbying and putting pressure on local legislators to pass laws that stop indiscriminate harvesting of these and other fish and seafood. Additionally the CCA is very instrumental in the prevention of habitat destruction and habitat restoration. The goal of CCA-PNW is to recruit 3,000 new members in Washington and Oregon. A CCA-PNW Chapter is being formed in Yakima. Dues are \$25.00/year, you can join on-line at (www.ccapnw.org). Gary Loomis gave a very interesting and informative presentation with much more information than presented in this newsletter. He answered many questions and there was a long line of people waiting to join the CCA after the meeting ended.
- Raffle winners were: Pat Ruane who won a completely rigged steelhead rod assembled by Richard Sharp and including many goodies and a large tackle box, Ron DeMarquette a Motorola Talkabout set (2 radios) with a 20 mile range, Greg Baker a Big Chief smoker, Marilyn Steele a large tackle box, Russ Wyer a \$20.00 gift certificate to Sportsman's Warehouse, John Prather a crank operated LED headlamp, and Don McBride and Mark Tavelli each won a hat.

REVISED QUALITY TRIP DRAWING RULES: The Quality Trip drawing rules were revised at the December 18 Board of Trustees meeting and are shown below. Entry tickets for the 2008 Quality Trip can be purchased at the January, February and March General Meetings and at the Wild Game Dinner, until the maximum of 100 tickets have been sold

- 1. Only RR&GC members with current dues paid through April 1 of following year are eligible to purchase up to 2 entry tickets each. Example: for drawing in March 2008, a member must have dues paid through April 1, 2009.
- 2. Tickets are \$20.00 each, the value of the trip (maximum amount reimbursed to winner) will be \$2,000.00.
- 3. A minimum of 50 and a maximum of 100 tickets will be sold. If less than 50 tickets are sold, no winner will be drawn and members who purchased tickets will be reimbursed.
- 4. Entrants must be 18 years of age or older at the time of the drawing to purchase tickets.

- 5. RR&GC members with a family membership, the spouse and eligible dependents (18 years or older) may also purchase up to 2 tickets each.
- 6. The drawing will be held at the annual RR&GC Wild Game Dinner. You do not need be present to win.
- 7. The winner will select a partner who must be a member of the RR&GC and who must also have participated in the drawing.
- 8. An alternate will also be drawn in the event the winner's trip cannot be taken as approved. The alternate will select his/her own partner who must also be a RR&GC member and also have participated in the drawing.
- 9. A written copy and a presentation in person (winner or partner) of the proposed trip must be provided to the RR&GC Board in either the May or June Board meeting for Board approval.
- 10. The winner must have confirmation of key trip logistics (e.g., guide services, airline tickets, lodging, etc.) by August 1 and the trip taken before December 31 of the year of award. If the trip cannot be confirmed in the allotted time frame (prior to September 1). The winner shall forfeit the trip and the trip will be awarded to the alternate. The alternate will follow the same criteria as the original trip winner, with the alternate presenting his proposed trip to the RR&GC board by the September board meeting.
- 11. In the event that the approved trip cannot be taken, the winner shall notify the RR&GC President immediately upon the winner's realization that the trip cannot be taken as approved.
- 12. Quality trip funds will be allotted as reimbursements after the winner has paid for portions of the trip. For example reimbursement for booking fees, airline tickets, etc. Note a check for reimbursement will not be provided to the winner prior to incurring costs without Board approval.
- 13. The winners will present a program, describing their Quality Trip, at a General Meeting of the membership in February or March prior to the next RR&GC Wild Game Dinner.
- 14. The winners will provide a written summary of the completed trip, including logistical details such as travel distances and costs, lodging details and expenses, guide expenses and license costs, name & addresses of lodging & guides, photos and other details. The report will be published on the Club website. A good reference for the report format are previous Quality Trip reports that are on the website.
- The winner will sign and date a copy of these rules, as an acknowledgment of understanding of the rules. The President of the RR&GC will send a letter notifying the winner of the trip approval.
- 16. The RR&GC board may, if requested, modify these rules for special circumstances.

2007 TRI-CITIES SPORTSMEN SHOW/LUNKER/LAKE/PELLET RANGE: Dates for the Tri-Cities Sportsmen Show at TRAC including Lunker Lake and the Pellet Range are January 18, 19, and 20, 2008. The Club will man the Lunker Lake Fishing Pond and help man the Air Rifle Shooting Range for the 15th consecutive year at the Tri-Cities Sportsmen Show on Friday, Saturday and Sunday January 18-20 at the TRAC facility outside Pasco. Many volunteers will be needed to man the pond in 4 and 5 hour shifts. Some members have already signed up and some have been contacted by Rick Nelson to help at Lunker Lake or Clare Cranston to help at the Air Rifle Range. If you have not volunteered and you wish to volunteer please call Rick Nelson at 628-2636 or Clare Cranston, for the Air Rifle Range, at 547-6273. Your duties at Lunker Lake will consist of baiting the hook for each child, removing the fish, after it is caught and placing it in a plastic bag after you have dispatched it. You will get a big kick out of working with the kids. A group of about 6 volunteers or more will be needed Thursday morning January 17, starting at 9:00 A.M., to set up the fishing pond. During the show a minimum of 16 volunteers per shift will be needed to man Lunker Lake. Shift times are 9:00 A.M. to 3:00 P.M. Thursday the 17th for set up of the fishing pond. Shift times for Friday the 18th are 1-5 P.M. and 5-9 P.M. Saturday the 20th, shifts will be from 10 AM-12: 30:00 P.M., 12:30-3:30 P.M. and 3:30-8 P.M. Sunday the 21st shifts will be from 10 AM-2 P.M. and 2-5 P.M., the last shift will stay over at 5:00 P.M. to help disassemble the pond. The Air Rifle Shooting Range will be manned again this year under the direction of Clare Cranston. FEBRUARY GENERAL MEETING

The topic of the February 5General Meeting is 'Walleye Fishing' and will be presented by Club member Richard Sharp. The meeting will be at the usual place, the City of Richland Maintenance Facility, Exit 3 from I-182 to Queensgate Drive across from the Walmart store at 7:00 pm. Walleye fishing in the Columbia River heats up at this time of the year. Mike Hepper from Richland, caught a 19.3-pound walleye Feb. 5, 2007 on the Columbia River above McNary Dam and set a new state record for the largest walleye caught in Washington waters, it was 33.7 inches long, with a girth of 22.24 inches. Note that the date of this General Meeting is also February 5. Richard Sharp is an experienced angler as evidenced by his earlier presentations on Sturgeon fishing, Salmon Fishing and Steelhead fishing, a few months ago. Richard will also present the 'Tip(s) Of the Month' at the meeting. He will discuss and demonstrate tackle, lures, techniques and where to fish for walleye. This will be a heavily attended meeting so be sure to come early to get a good seat and perhaps stay late since Richard will be answering a lot of questions.

- I'm sure that one of the many prizes in the raffle drawing, held at the end of the meeting, will be a completely rigged walleye rod, reel (with line) lures and other items necessary for walleye fishing,

Please bring game and fish donations for the Wild Game Dinner to the February and March General Meetings. The meat will be placed in an ice chest(s) and transported to a freezer. So far the donations have been very slim.

March 29 Wild Game Dinner tickets for \$15.00 each will be on sale at the meeting. Speaker at the dinner will be Gaylord Mink and his topic will be "ALE 2007: Before and After the Fire." The video will show the impacts of the August 2007 fire on the wildlife and plants with an emphasis on activities of the Rattlesnake Hills (Hanford) elk herd.

<u>JANUARY GENERAL MEETING REPORT</u>: Incoming President Rick Nelson opened the January meeting on a cold snowy, wet/icy evening to a group about 35 people. Because New Years day fell on the first Tuesday of the month, the meeting was held on the second Tuesday at the Battelle Auditorium. Announcements were made by Rick, Mike Estes, Gene Van Liew, Jerry Zeitler, Howard Gardner and Tim Sumner who substituted for Richard Sharp.

- Program Chairman Angie Conant introduced the Tip of The Month speaker. Don Hunter. Don went winter Steelhead fishing on Monday, December 7 behind McNary Dam. He launched his boat on the ramp at the Washington side of the Dam. And proceeded to fish alone on the Oregon side. After fishing on the Oregon side he moved to the center of the river and continued fishing. He had a strike and as he reached for the rod he went over the gunwale of his boat into the river. He was wearing a manually inflatable PFD and finally was able to climb over the transom into the boat. By the time he got into the boat he was confused and probably hypothermic. He did not put on dry clothes and finally was able to start the outboard and raced to the boat ramp, beached his boat and climbed up the ramp one step at a time and walked slowly to his camper, crawled in and changed to dry clothes and slept for 13 hours. The next day Mark Sherer recognized Don's boar that was adrift, he towed the boat back to the ramp and went to the camper and woke up Don. Don went home and by Tuesday he wasn't feeling well, he went to a doctor Wednesday because he had difficulty breathing and learned that he had strained his chest muscles while attempting to get into the boat Don knows that he should have had someone in the boat with him, but he enjoys fishing alone. He estimates that he was in the river for nine minutes: The air temperature was 34° and the water temperature 46°. Don believes that a step ladder on the side of the boat would have allowed him to get back into the boat almost immediately.
- Angie then introduced the main speakers Howard Gardner and Larry Martin who spoke about coyote calling and fur handling. According to Howard, one of the fascinations about coyote hunting is that it requires less work than other forms of hunting. They showed and described different calls they use when coyote hunting. Two mouth calls that they demonstrated were open and closed reed calls. They also demonstrated two battery powered electronic calls. Decoys can also be used in conjunction with the calls. The decoys can be stuffed objects that imitate squirrels or rabbits, attention getters such as feathers can be used to get the predators attention. The electronic call and/or decoys should be positioned so that they are visible to the hunter. Different hunting techniques that they use were described. Howard's favorite rifle is a 220 Swift. Larry uses a 22-caliber center fire rifle and also 0.17 caliber rifle. Howard showed the shooting stick that he uses, he made it from two long 1/2" wooden dowels joined together with a rubber band(s). He also showed and described the equipment/(goodies) that he carries in his pack while hunting water bottle, binoculars, GPS, compass, food, camera, flashlight, knife, home made tail stripper, skinning gloves, insect spray that he sprays into a plastic bag containing the skinned hide, fire starter and candle, poncho and toilet paper. They also described the skinning, washing and drying techniques for skinned hides. Howard also demonstrated the fleshing knife and technique he uses on a fresh hide. Larry and Howard answered many questions from the audience.
- Raffle prize winners were Pat Travis who selected a combination drill bit set, Dan Edwards picked the assembled Steelhead spinning rod and reel, complete with lures and other goodies assembled by Richard Sharp. <u>WELLSIAN WAY JUVENILE POND</u>: - (Howard Gardner) The following information was assembled by Howard for the City of Richland. Here is a brief history of the Club's involvement in the Pond:

Club records show that the Wellsian Way Juvenile Pond was constructed in 1950 under the leadership of Club Member Art Mitchel who lined up the volunteer heavy equipment operators and their equipment. Other Club members participating were: Ken Parchen, Rex Bissel and Al Olson. The work was done in cooperation with the Richland Recreation Unit. I would guess that the Pond was first planted with trout in 1950 or 1951 by the Washington State Dept. of Game. The first record of the Club arranging for trout planting with the Dept. of Game was in the spring of 1956. Also, in March 1957, Club members installed an intake pipe and weir box to help maintain the water level. A fish screen was also installed, the total effort required 150 man-hours of effort. Members involved were: Dave Byrd, Jerry Zeitler, Lane Bray, Ernie Berreth, George Houtrouw, Pat Hogan, Ward Lyon, Ted McKenzie, Kenny Schulz and Howard Gardner. Smallmouth Bass were planted by Club members in April 1957.

Starting probably in 1950-51, the Washington State Game Dept. Game Fish regulations listed the Pond as Wellsian Lake with an April opening date and it was open through Oct. 31 for juveniles only(under 14 years of age). My records go back to 1955 and the Pond was managed this way through 1981. Through the years the Club arranged for the trout plants with the Washington State Dept. of Game and had periodic work parties for maintenance and cleanup. One reference states that the Pond was stocked with 25,000 trout in 1963. Also, in April 1965 the Club received a letter from Ernie Curtis, Recreation Director, City of Richland thanking the members of the Junior Richland Rod and Gun Club for their assistance in cleaning up the Pond on March 13 prior to its opening in April. Another reference acknowledges their assistance in the 1966 cleanup. Other references for the Club's activities with the pond were in May 1973 and April 1974.

I don't have any information on why the last trout stocking was in 1981 and what ultimately happened to the Pond.

Columbia River' to the railroad bridge upstream on the Columbia River is now treated in the Steelhead regulations as the Snake River. Railroad Pond in the coulee that runs from Mesa to Connell will not be stocked with fish because it is private property. As a result the Triploid Trout that were to be stocked in Railroad Pond will be stocked in Powerline Lake. Starting May 1 a second Steelhead Sport Catch Record card can be purchased when the first on is filled. Paul stated that Emergency Regulations on the WDFW Web Site should be checked to determine current salmon and steelhead regulations. Paul also said that walleye and other warm water fish survey data for lakes that are sampled are available on the WDFW Web Site under Fish and Shellfish Science - Freshwater - Warm water Enhancement Program Reports. Paul announced that the Duportail Boat Launch on the Yakima River is now open. The launch is shallow and not really suitable for large boats. Sockeye counts at Bonneville Dam are about three times what Columbia Basin harvest managers had originally expected. By July 21, more than 213,000 had been counted, four times the 10-year average and higher than any year since 1959. Even the tiny, ESA-listed component of the run that heads up the Snake River and aims for Idaho's Redfish Lake is showing signs of life. THREE YOUTH ATTENDED WASHINGTON STATE YOUTH CONSERVATION CAMP: Danica Marlin attended the Girls Camp at Orcas Island from July 13 to July 19. Cody Gaunt and Julian Zapien attended the Boys Camp from July 20 to July 26. All three were sponsored by the Club to the Camp.

THE REPAIR OF SEVEN FIRE DAMAGED CISTERNS (GUZZLERS): - (A description of the efforts required to repair seven guzzlers as logged by Larry Martin.) Seven guzzlers that were damaged by a fire started by a train were repaired. Hopefully the cost of repairs will be reimbursed by the railroad. The guzzlers are located on the B&B Farms in Finley. The owner Brian Wake needed help repairing the guzzlers. Larry Martin met with Brian 3/31/08 and they toured the damaged guzzlers, photographed them to document the damage and estimated the damage costs. (A total of 14 man hours was expended on this task.)

- On 4/18/08 Brian contacted Larry and said he had all the lumber construction material except for the metal for the roofs.
- On 4/21/08 Larry picked up the lumber from Brian and transported it to his garage and fabricated eight rain catcher frames, he ran out of screws and was short three 2x4s to complete the 9th frame. (A total of 10 man hours was expended to construct the frames.)
- On 4/26/08 Larry Martin, Jeff Martin and Dale Schielke worked on Cisterns 100 and 101 and met at Finley Middle School at 8:30am. These two guzzlers were completely destroyed, tanks and all. They completed both guzzlers except for the metal roof and finished at 3:00pm (21 Man-hours).
- On 5/5/08 Larry Martin and Howard Gardner worked on Cisterns 96 and 97. Met at 8:30am at Larry's house and completed repair on 97, and decided to return later to complete 96. (16 man-hours)
- On 5/10/08 Larry Martin and Howard Gardner finished Cistern 96' They found Cisterns 98 and 102 and created GPS track log s for them. They found the remains of a coyote under the collapsed rain catcher roof on cistern 98, apparently the coyote tried to hide from the fire. They photographed the burned carcass. (15 man-hours)
- On 5/19/08 Larry Martin and Howard Gardner repaired Cistern 102, They met at Larry's house at 8:30am and were done by 12:30pm. (9 man-hours)

- on 5/24/08 Larry Martin and Bob Kolowith repaired Cistern 99. Met at 8:00am at Finley Middle School. Brian Wake had the corrugated sheet metal and they were able to complete this cistern. They forgot to install ID tag. They finished at 12:30pm and brought the fiberglass tank top back to Brian's shop, Larry will repair the hole in it later. (11man-hours)
- On 5/27/08 Larry Martin put the metal roof on Cisterns 100 and 101 and the ID tag on 100. Picked up old parts of Cistern 100 and took them back to Brian's shop. 4:00pm to 8:30pm. (4 man-hours)
- On 5/31/08 Larry Martin, Larry Noggles, Dale Berndt and Joe Berndt met at Finley Middle School at 8:00am. They replaced the Cistern 98 tank which still had water in it. They used a couple five-gallon buckets to remove water before they could pull the old tank out. They took the burned up parts back to Brian's shop. Brian took all the old parts to the dump later. (22 man-hours)
- On Wednesday, 6-11-08 Mike Czebotal and Larry repaired a guzzler near Wallula Junction. This guzzler was damaged by fire a couple years ago. The tank was in good shape but the rain catcher wings were burned. All but one of the rain catcher legs were replaced r with posts made from old 3 inch sprinkler pipe which should hold up better in a fire. They were able to save the corrugated metal roof which was a significant savings. (10 man-hours) There is one more guzzler about a half mile from this guzzler that is also damaged from the same fire which will be repaired later this year.
- Permission was obtained to go in and repair and fence-in a couple guzzlers South of Coffin Rd. which were damaged by cattle. This project may have to wait until next year.
- One of the guzzler fiberglass tank tops was salvaged from the project at the B&B farms in Finley. Larry repaired a hole burned into the tank with a fiberglass patch. Mike Keller picked up the repaired tank at Larry's home and took it to Windmill Ranch to store it for later use. (3 man-hours)

2008 WATERFOWL SURVEY SHOWS DUCKS BREEDING FARTHER NORTH, BYPASSING DRY PRAIRIES

(A USFWS news Release) - The preliminary estimate of total ducks from the 2008 Waterfowl Breeding Population and Habitat Survey was just over 37 million, which is a nine percent decline from last year's estimate, but still 11 percent greater than the 1955-2007 average. In the U.S. and Canadian prairies, population estimates of many species declined; while populations increased in the boreal forest to the north, likely reflecting in part those birds that overflew the prairies because of drier habitat conditions there.

The Waterfowl Breeding Population and Habitat Survey, the largest and most comprehensive survey of its kind in the world, samples two million square miles across the north-central and northeastern United States, south-central, eastern, and northern Canada, and Alaska. The survey estimates the number of ducks on the continent's most important nesting grounds. Overall, habitat conditions for breeding waterfowl in 2008 were generally similar to or somewhat worse than to conditions in 2007. The total pond estimate (Prairie Canada and United States combined) was 4.4 million ponds. This was 37 percent below last year's estimate of 7.0 million ponds and 10 percent below than the long-term average of 4.9 million ponds.

The annual survey guides the Service's waterfowl conservation programs under authority of the 1918 Migratory Bird Treaty Act. The Service works in partnership with state biologists from the four flyways - the Atlantic, Mississippi, Central and Pacific - to establish regulatory frameworks for waterfowl hunting season lengths, dates, and bag limits.

Highlights from the survey in the north-central United States, south-central and northern Canada, and Alaska (the traditional survey area) include:

- Mallard estimated population of 7.7 million birds, similar to last year's estimate of 8.3 million birds and the long-term average.
- Blue-winged teal estimated population of 6.6 million birds, similar to last year's estimate of 6.7 million birds and 45 percent above the long-term average.
- The estimated population of green-winged teal stands at 3.0 million and is similar to last year and 57 percent above the long-term average.
- The estimated population of 2.7 million gadwall was 19 percent below last year and 56 percent above the long-term average.
- The estimated number of 1.1 million redheads was similar to last year and was 66 percent above the long-term average.
 The canvasback estimate was 489,000 which is 44 percent below last
- The canvasback estimate was 489,000 which is 44 percent below last year's estimate of 865,000 and 14 percent below the long-term average.
- The estimated abundance of northern shovelers (3.5 million) was 23 percent below last year and 56 percent above their long-term average.
- Scaup (lesser and greater combined), estimated at 3.7 million, were similar to last year and 27 percent below the long-term average.
- The 2.6 million estimate for northern pintails is 22 percent below last year and 36 percent below the 1955-2007 average.
- Population estimates for American black ducks, ring-necked ducks, American

ODFW UNVEILS OREGON HUNTING ACCESS MAP: (Excerpted from "The Outdoor Wire'

http://www.theoutdoorwire.com/) SALEM, Oregon - Oregon's fall hunting season is fast approaching and the perennial question "Where can I go hunting?" will be much easier to answer this year. ODFW has unveiled its new Oregon Hunting Access Map, http://www.dfw.state.or.us/resources/hunting/map/index.asp, a great tool to find out where to hunt, especially for people new to hunting or new to the state. Even experienced Oregon hunters are likely to discover a new hunting location by exploring the comprehensive list of opportunities in a centralized place

The map features state wildlife areas, national wildlife refuges, private lands open to hunting through ODFW's Access & Habitat (A&H) and Upland Cooperative Access (UCAP) programs, Travel Management Areas on private timberlands open to hunting, and Willamette River Greenway properties that allow hunting. Because the map is based within Google MapsTM, users can calculate distance and driving directions to the hunting area, switch between map, terrain and satellite views, zoom in and out of areas, and customize the map to their liking.

A descriptive bubble for each area provides further information about the principal species hunted, size of the area, acces periods and special regulations. Big game and game bird icons will help hunters quickly determine if an area is right for them. In addition, many of these areas have links to further information-PDF maps, harvest reports and regional hunting reports. Users can also discover more about "by-permission-only" hunting on certain A&H and UCAP properties from the orange icons. "This map makes it easy for those just getting started hunting in Oregon to figure out where to go," said Matthew Keenan, ODFW's Access and Habitat program coordinator. "Experienced hunters can explore their favorite and as-yet-undiscovered hunting locations from one centralized place."

Every hunter knows scouting is key to success, and these Google Maps™ make it easy to start scouting from home," Keenan added.

The interactive map lets users leave comments, too. "This map is a work-in-progress, and we want to hear from hunters about how to make it more useful and user-friendly," noted David Budeau, ODFW upland bird program coordinator. "In the future, we'll consider adding other opportunities such as popular hunting areas on BLM and Forest Service lands, and even creating additional maps for fishing, clamming/crabbing and wildlife viewing opportunities."

The maps should be used for reference only-hunters are still responsible for knowing their particular hunt's boundaries and regulations.

RR&GC MEAT RECOVERY PROGRAM: The first two game animal meat recoveries by the Club were in early September.

◆ Mike Estes received a call from Franklin County Dispatch about 6:20 A.M. September 4 concerning t a bull elk that had been hit by a vehicle on the Pasco-Kahlotus Highway. The elk had two broken legs and his suffering was ended by a Franklin County Deputy. Mike contacted Gaylord Pyle to serve as team leader on the recovery. Gaylord was assisted by Pat Travis, Paul Kison, and Jerry Zeitler. The animal was gutted, skinned, and the meat was deboned at the scene. Gaylord was able to contact the Union Gospel Mission and they requested that the meat be delivered to McCary's Meats in Basin City for packaging. Gaylord delivered the meat to Basin City and the 5x5 antlers were delivered to Officer Brian Fulton of WDFW Enforcement.

- WDFW Enforcement tried to contact Mike Estes on Friday morning September 5 and then called Lyle Gilk to see whether the RR&GC would be able to take possession of a mule deer that was harvested illegally near Paterson. Lyle made calls to several people to coordinate the activity and then was able to contact Mike Estes in the early afternoon. Mike made contact with Officers John Horn and Brian Fulton and arranged to meet them as they arrived back in the Tri-Cities from Oregon where they had recovered the animal. Donations of game meat including waterfowl, other unique game meat such as bear, boar, or cougar; upland birds and clean, boneless big game roasts and steaks are desired. Halibut, Steelhead and salmon are also needed. A good big game roast is the sirloin tip. It is boneless, relatively tender but dry, therefore it should be cooked with moisture in a closed pan. Every hunter, whether he cuts his own meat or not, can remove this roast as follows: (the diagram is shown on the Club's web site at http://rrgclub.tripod.com/rrgcclubnews). After skinning and while the animal is hanging, place your knife just below the animal's kneecap. Cut into the leg until you reach the leg bone, turn your knife and follow the leg bone until you reach the rump knuckle, then turn the knife 45° and cut out. Another good boneless roast is the round roast which can be cut in about the same manner. It is located just above the sirloin tip roast. Clean the meat or fish thoroughly, pat it dry and double wrap it; first with plastic wrap and then with waxed freezer paper. Be sure to squeeze all the air out around the meat (NO GROUND MEAT PLEASE). Seal with tape and mark package as to what it contains and with your name and hunting license number. Bring the package(s) to the General or Board Meetings. The packages will be placed in an ice chest(s) and then stored in a freezer. Your donations will help make the Wild Game Dinner a big success. SEPTEMBER 20 PHEASANT HUNT FOR HUNTER EDUCATION STUDENTS AT LIMITS GAME FARM: Thirty three-fortunate Hunter Education student graduates were treated to a pheasant hunt for stocked pheasants at the Limits Game Farm, north of Mesa, on Saturday, September 20, the first day of the Statewide youth-only bird hunt held Sept. 20-21

• Eighteen students hunted in the morning and the other fifteen hunted after lunch. Besides Hunter Education students from

- the Club's Hunter Education program, students from Connell, Mesa, Walla Walla, Lind and Prescott also participated. Each group traveled to the Connell Gun Club where they practiced shooting at clay pigeons. After they finished shooting, they traveled to the Limits Game Farm North of Mesa for the pheasant hunt. Before they hunted, the students were registered. participated in a safety lecture and discussion and were divided into smaller groups. Those who didn't have a shotgun were loaned one from a stock of shotguns provided by Clare Cranston. A coach was assigned to each student and each group was provided with a dog handler with a bird dog. A minimum of three pheasants had been set out earlier for each youth. The students hunted behind the dog and dog handler. Two youth, each with their coach, were behind the dog and handler. The other students and others, including an EMT and parents followed behind. As soon as a bird was located and flushed, one of the group of two shot at the bird. The other youth of the pair then rotated to the front and hunted until they each had a shot at a bird. The next pair then rotated to the front and took their turn. They continued shooting and rotating until all the birds were flushed. • The second group of 15 showed up later in the morning at the Limits Game Farm after they finished shooting clay pigeons at the Connell Gun Club. Both groups, their parents, the coaches, dog handlers and other helpers then retired to the 'barn' where two rows of tables had been set up. All were then treated to a lunch consisting of barbecued Tri-Tip beef steak, barbecued chicken breasts and thighs, Dutch Oven baked beans (prepared by Dave Myers and Rick Conant), bread rolls, potato chips, brownies (prepared by Marilyn Steele) and bottled water or soft drinks. The second group was first to go through the food line since they were going to hunt as soon as they finished eating. More than 100 people were served and the food was excellent. Everyone was able to go through the serving line until they were full. After lunch the second group then participated in a safety lecture and discussion and were divided into smaller groups. Those who didn't have a shotgun were loaned one from the stock of shotguns. They hunted in a similar manner as the morning group. The morning group did not fare as well as the afternoon group. The weather was clear and dry in the morning and the stocked pheasants were reluctant to flush and as a result the morning group had fewer shots than the afternoon group which hunted in cloudy weather after a short rain shower. The morning group harvested four and the afternoon group harvested eleven birds. Successful hunters from both groups cleaned their harvested birds under the direction of Bill Moulds. Before they went home, each youth received a beautiful engraved Pheasants Forever lock blade pocket knife courtesy of the Ringold Pheasants Forever Club and the Limits Game Farm.

U.S. FISH AND WILDLIFE SERVICE REOPENS PUBLIC COMMENT PERIOD ON 2007 PROPOSAL TO DELIST NORTHERN ROCKY MOUNTAIN POPULATION OF GRAY WOLVES UNDER THE ENDANGERED SPECIES

ACT (Excerpted from a USFWS news release) The U.S. Fish and Wildlife Service announced 10/24/2008 it is reopening the public comment period on its proposal to delist the gray wolf in the northern Rocky Mountains. The public will have until November 28, 2008, to submit their comments to the Federal eRulemaking Portal at http://www.regulations.gov or via U.S. mail or hand delivery to: Public Comments Processing, Attn: RIN 1018-Au53; Division of Policy and Directives Management; U.S. Fish and Wildlife Service; 4401 N. Fairfax Drive, Suite 222; Arlington, VA 22203. Through a notice in the Federal Register scheduled to publish on October 28, 2008, the Service is asking the public to provide comments and any additional information on the 2007 proposal to delist wolves. The Service is seeking additional information on a variety of topics related to the delisting. More details are available in the Federal Register notice which will be posted along with associated materials at the Service's northern Rocky Mountains wolf website: http://westerngraywolf.fws.gov. On July 18, 2008, the U.S. Federal District Court in Missoula, Montana, issued an order immediately reinstating Endangered Species Act protections for wolves in the northern Rocky Mountains. In September 2008, the Service requested the court vacate and remand the final delisting rule back to the Service. The court granted the Service's request on October 13, 2008. At this time, the northern Rocky Mountain population of gray wolves remains under the protection of the Endangered Species Act. The area affected by this ruling includes all of Montana, Idaho, and Wyoming and the eastern one-third of Washington and Oregon and parts of north-central Utah. Management of the northern Rocky Mountain population of gray wolves is now governed by the same Endangered Species Act protections that were in effect before wolves were delisted on March 28, 2008.

The minimum recovery goal for wolves in the northern Rocky Mountains is 30 breeding pairs and at least 300 wolves for three consecutive years, a goal that was attained in 2002 and has been exceeded every year since. The proposed northern Rocky Mountain population of wolves includes all of Montana, Idaho and Wyoming, the <u>eastern one-third of Washington and Oregon</u>, and a small part of north-central Utah. Gray wolves were previously listed as endangered in the lower 48 states, except in Minnesota, where they were listed as threatened. The wolf population in the Midwest was delisted in early 2007 but that decision was reversed in court in October 2008.

He started off his presentation by relating and showing photos of his recent fishing successes.
- Richard gave the recipe for the *Tuna Balls* that he uses for salmon: one 6 oz. can of the cheapest and stinkiest tuna canned in water you can buy, two drops of red food dye, 2 tablespoons brown sugar and one teaspoon table salt. Wash your hands in *Boraxo* and use plastic not metal utensils. Squeeze the liquid from the tuna, mix the ingredients and form into 5 or 6 balls (the balls can be frozen for later use). Wrap each ball with fine netting such as used for salmon eggs and twist the end of the letting and tie with *Magic Thread*, do not trim the loose end of the netting. Fasten the ball to a size 2/0 with an egg loop knot around the center of the ball with hook facing up.
- He showed and demonstrated the different rigging methods he uses for salmon and Steelhead, showed a knot tying tool that can make bobber stopper loops and gave a reference to a web site that shows animated knots: www.animatedknots.com. He showed maps which illustrated the various locations where he fishes for salmon and Steelhead. Richard again gave a very

informative presentation as evidenced by all the seats in the room being filled. Many stayed after the presentation and asked Richard many questions.

- 2006 NATIONAL SURVEY OF FISHING, HUNTING, AND WILDLIFE-ASSOCIATED RECREATION: (A USFWS news release) A new report recently released by the U.S. Fish and Wildlife Service shows that expenditures for wildlife watching are equivalent to the revenues generated from all spectator sports, amusement parks and arcades, non-hotel casinos, bowling centers and skiing facilities combined. Using data from the 2006 National Survey of Fishing, Hunting, and Wildlife-Associated Recreation, the Service's new addendum report Wildlife Watching
- in the United States: The Economic Impacts on National and State Economies in 2006 shows wildlife watching not only contributes significantly to people's enjoyment of the outdoors but is a major factor in the state and national economies.
- In 2006, the direct expenditures of wildlife watchers generated \$122.6 billion in total industrial output. This resulted in 1,063,482 jobs, a federal tax revenue of \$9.3 billion, and a state and local tax revenue of \$8.9 billion. The report details the economic impacts of wildlife watching expenditures by State. The top 5 States ranked by economic output include California, Florida, Texas, Georgia and New York. Direct expenditures by wildlife watchers were for items such as cameras, binoculars and bird food, as well as trip-related expenses such as lodging, transportation and food.
- The report addresses participation nationwide in wildlife watching, associated expenditures and estimates of the total economic activity generated by these expenditures. In addition, it addresses the total employment and income associated with wildlife watching expenditures and estimates of the generated state and federal tax revenue. In 2006, nearly 71 million Americans (16 years of age and older) spent more than \$45 billion observing, feeding, and photographing wildlife.

The conduct rules were enacted earlier this year to protect fish and wildlife habitat, ensure public safety and promote responsible use of public lands. WDFW oversees approximately 900,000 acres of public land divided into 32 designated wildlife areas across the state. The lands are managed to protect fish and wildlife species, preserve habitat and provide recreational opportunities for the public. The department also maintains more than 150 water access sites, which provide boating access to lakes, rivers and marine areas in or near state wildlife areas. PETA: Save the "Sea Kittens" & Hunting for Those Under 18 (U.S. Sportsmen's Alliance news releases) A recently unveiled new marketing campaigns devoted to ending fishing as we know it. PETA plans to do this by not calling a spade a "spade," or in this case a fish a "fish." From now on PETA wants everyone to call fish "sea kittens" because no one would ever want to "hurt a sea kitten." According to PETA, "sea kittens are just as intelligent (not to mention adorable) as dogs and cats, and they feel pain just as all animals do." They go on to call on their supporters to send an e-mail to the director of the Division of Fish and Wildlife Services (FWS) asking that the "hunting of sea kittens" be prohibited as it is a "glaring contradiction of FWS mission. On November 11, PETA sent a letter to the Governor of Arizona, Janet Napolitano, urging support of legislation that would ban hunting by anyone younger than 18 saying that hunting teaches "children to see others

DECEMBER GENERAL MEETING

- The December meeting will be 7:00 p.m. Tuesday, December 2 at the City of Richland Maintenance Facility, Exit 3 from I-182 to Queensgate Drive, across from the Wal Mart. The speaker will be Anthony Novack, WDFW Deer/Elk Conflict Specialist. Anthony also worked as a wolf biologist for two seasons with the Nez Perce Tribe in Idaho. He has been involved with development of the current Washington State wolf management plan. His initiative is to do some outreach directly with the sportsmen's organizations in the State. The wolf management plan is currently in a draft form and he has developed a presentation to deliver to the various hunting organizations in the region and to talk candidly about wolf impacts to game populations. Come to the last meeting of 2008, learn about the management plan and express your suggestions and comments while the plan is still in the draft form.
- The Tip OF The Month presentation, "How to load and secure game meat on a pack frame," will be given by Howard Gardner.

NOVEMBER GENERAL MEETING REPORT: Club President Rick Nelson opened the meeting and asked visitors to introduce themselves. Angie Conant was not able to attend. Rick made several announcements. Mike Estes talked about the Club's Meat Recovery Program. Lyle Gilk talked about the third Meat Recovery of a deer (see description later in this Newsletter.) Dave Myers, as per Clare Cranston, stated that a volunteer from the Club is needed to serve on the Warmwater Fish Advisory Committee by December 1. Dave answered several questions from the audience.

- The Tip of The Month presentation was given by Howard Gardner. Howard and his wife went hunting in Montana in November. They left with their pickup and camper on a Thursday, arrived in Bozeman Thursday and on Friday traveled to Miles City and then to the ranch where they hunted. He hunted for pheasants, deer and antelope. It snowed 8"-10" on Sunday and started melting by Tuesday. In addition to harvesting some pheasants he bagged a doe deer, a small antelope and a buck antelope. They left Friday to return home. He related some of the problems they encountered such as a flat tire on their truck that they were not able to repair until they came to a Les Schwab tire store.
- Marie Zoraske, Water Quality Specialist from the South Yakima County Conservation District, was the first main speaker, and her topic was The Lower Yakima River Eutrophication Study. She spoke to the Club several years ago about the same

topic and her present talk was about the end of the five year study on the Lower Yakima River. She passed out an outline of her Power Point presentation for the audience to refer to during her talk. The study covers an approximate 115-mile stretch of the river starting above the City of Yakima and ending in Richland. The river was divided into three sections, the Zillah Reach, Mabton Reach and Kiona Reach. Variables addressed in the study were: dissolved nutrients such at nitrogen and orthophosphates, dissolved oxygen and pH in the river water, Water Stargrass, and algae. Each of the three sections was unique and different from the others. Marie described the structure and properties of each section. She went into a lot of detail about the information gathered from each section. At the end of her presentation she recapped the information and some of the conclusions that they arrived at. The next step in the study is for the Washington Department of Ecology to formulate a Clean up Plan. Marie fielded and answered many questions from the audience. Her presentation was well planned, effective and very informative, she did a really good job!

• Rachel Little, Fish Biologist/Education Coordinator for the Benton Conservation District, was the second speaker. Rachel is well known to the Club because of her association and leadership in the Salmon In The Classroom project. She has also been very involved in a project(s) to determine methods to remove Water Stargrass or inhibit its growth in the Kiona Reach. Prior to Stargrass infestation, the Kiona Reach was heavily used be spawning salmon, because of the infestation, salmon are now spawning upstream from the Stargrass. Stargrass was removed from 50 ft. X 50 ft.test plots either by pulling or cutting to determine if salmon would return to spawn. The results were negative. In some cases the Stargrass was replaced by Curlyleaf Pondweed. The next step might be to remove the Stargrass from much larger plots. Removal and disposal of Stargrass is very

difficult and expensive.

Rachel also spoke about the Salmon In The Classroom project. She stated that volunteers are needed for different aspects of the program such as salmon egg delivery, salmon dissection demonstrations in the classrooms and monitoring and maintenance of fish tanks. If you are willing to help, give Rachel a call at (509)832-1329. At present there is a total of 56 fish tanks in 4th-5th grade classrooms in Eastern Washington. Every grade school in Pasco now has a fish tank. Cost and setup of a fish tank is about \$1700. A backup fish tank is now installed and operating at the Sportsman's Warehouse in Kennewick. The backup tank will be used if a classroom fish tank fails. The Salmon Summit this year will take place on May 11 & 12: reserve these dates-many volunteers will be needed. Rachel answered many questions about the Stargrass removal and Salmon In The Classroom. She must be a very busy lady. Many thanks to Marie and Rachel for taking the time out to come to the Club and inform and educate us.

ATTENTION HUNTERS!!: The hunting season has started and once again it is time to set aside some of your harvest for the Club's annual Wild Game Dinner that will be held March 28, 2009.

• Donations of game meat including waterfowl, other unique game meat such as bear, boar, or cougar; upland birds and clean, boneless big game roasts and steaks are desired. Halibut, Steelhead and salmon are also needed. A good big game roast is the sirloin tip. It is boneless, relatively tender but dry, therefore it should be cooked with moisture in a closed pan. Every hunter, whether he cuts his own meat or not, can remove this roast as follows: (the diagram is shown on the Club's web site at http://rrgclub.tripod.com/rrgcclubnews). After skinning and while the animal is hanging, place your knife just below the animal's kneecap. Cut into the leg until you reach the leg bone, turn your knife and follow the leg bone until you reach the rump knuckle, then turn the knife 45° and cut out. Another good boneless roast is the round roast which can be cut in about the same manner. It is located just above the sirloin tip roast. Clean the meat or fish thoroughly, pat it dry and double wrap

it; first with plastic wrap and then with waxed freezer paper. Be sure to squeeze all the air out around the meat (NO GROUND MEAT PLEASE). Seal with tape and mark package as to what it contains, your name and hunting license number. Bring the package(s) to the General or Board Meetings. The packages will be placed in an ice chest(s) and then stored in a freezer. Your donations will help make the Wild Game Dinner a big success. Good hunting and good fishing!

2009 TRI-CITIES SPORTSMEN SHOW/LUNKER/LAKE/PELLET RANGE: Dates for the Tri-Cities Sportsmen Show at TRAC including Lunker Lake and the Pellet Range are January 16, 17, and 18, 2009. The Club will man the Lunker Lake Fishing Pond and help man the Air Rifle Shooting Range for the 16th consecutive year at the Tri-Cities Sportsmen Show on Friday, Saturday and Sunday, January 16-18 at the TRAC facility outside Pasco. Many volunteers will be needed to man the pond in 2 1/2 to 4 hour shifts.
