## **Tri-Cities Sportsmen Show**

Volunteers are needed to help at the Tri-Cities Sportsmen Show which will be held January 26-28, 2024 at the HAPO Center (formerly TRAC) in Pasco. RRGC will be hosting the Air Rifle Range and staffing the Lunker Lake Fishing Pond again this year. Both venues are for youth 12 years and under. Show hours are Friday, Noon to 7:00pm; Saturday, 10:00am to 6:00pm; and Sunday, 10:00am to 4:00pm. Fishing Pond set up will be on Thursday morning. Sunday is Kid's Day with free fishing. Volunteers are needed to work shifts each

day of the show and to set up and disassemble the fishing pond. Volunteers receive free admission and it is a lot of fun assisting the kids. Sign up information will be available at our December meeting.

## Quality Trip Rules

It was announced last month that the rules for the 2024 Quality Trip drawing have been revised. Members who perform volunteer work on a number of RRGC projects and activities are eligible to purchase additional chances in the drawing. A <u>free chance</u> in the raffle will be offered to any member who 1) purchases a chance in the drawing, and 2) accumulates 20 or more hours of volunteer work on club sponsored projects during the calendar year (January 1 through December 31) preceding the drawing. A <u>second free chance</u> will be offered if the individual purchases 2 or more chances and accumulates 40 or more hours as described in the preceding sentence. No member may be awarded more than two free chances in the drawing. Volunteer service on the following projects will count towards the accumulated hours.

- Tri-Cities Sportsmen Show Lunker Lake and Youth Pellet Range (set-up, tear down, shift work)
- Wild Game Dinner (food preparation, cooks, equipment transport, event set-up and tear down)
- KOE Special Needs and Kids Fishing Days (rod assembly, mentoring, event activities)
- Angler Education (class instructors and assistants)
- Hunter Education (instructors and assistants during classes and range day)
- Youth Pheasant Hunt (mentors and dog handlers)
- Introduction to Firearms Class (instructors and assistants)
- Salmon in the Classroom (egg and supply deliveries, carcass deliveries, dissections, fish release)
- Habitat (water guzzler installation, monitoring, maintenance, removal or relocation)
- Wood Duck Nests (construction, installation, monitoring and maintenance, student instruction)
- RRGC wildlife related group projects in support of WDFW, USFWS, and other agencies.

## **Grizzly Bear Restoration Plan**

The comment period on the Environmental Impact Statement (EIS) for the National Park Service (NPS) and U.S. Fish and Wildlife Service (USFWS) draft plan to reintroduce grizzly bears to the North Cascades Ecosystem (NCE) in Washington closed on November 13, 2023. The EIS identified three potential alternatives. Alternative A, referred to as the noaction alternative, would continue existing management practices. Grizzlies would not be reintroduced and would depend on migration of bears from British Columbia, Alberta, and Idaho to populate the NCE. Alternatives B and C are similar to each other and propose a restoration population goal of 200 grizzly bears in the NCE. Bears would be captured in other states or Canadian provinces, relocated, and then released in the NCE. The federal agencies would aim to release 3 to 7 grizzly bears per year for 5 to 10 years to achieve an initial founder population of 25 bears. Thus, it might take 60 to 100 years for grizzlies to reach the restoration goal of 200 bears in the NCE.

The alternative preferred by federal agencies in the 2017 EIS was Alternative B in the new EIS: restoration with existing Endangered Species Act (ESA) protections. The federal plan to release grizzlies in Washington was heavily opposed in 2017, which resulted in the Secretary of the Department of the Interior putting a hold on the proposal. The hold lasted about 6 years until the revised EIS was released in September 2023. Many of the concerns expressed previously by citizens who live near or recreate in the area near the NCE about the risk of death, injury, or property loss caused by grizzly bears resulted in a new Alternate C for this EIS which would designate grizzly bears in the US portion of the NCE and surrounding areas as an ESA section 10(j) Nonessential Experimental Population (NEP). The NEP designation would allow the bears to be "managed" if and when conflict situations should arise. Alternative C would also create 3 management zones covering nearly the entire state into which grizzly bears could be reintroduced. Those zones include Cascade Mountains all the way from Canada to Oregon, the Blue Mountains, the Olympic Peninsula, and everywhere except the portion of northeastern Washington which is already part of, or adjoins, the Selkirk Grizzly Bear Recovery Zone.

RRGC sent a letter in April 2017 opposing the reintroduction of grizzly bears as a violation of state law RCW 77.12.035 and an unnecessary risk to Washington's citizens, wildlife, and property. We continue to believe that Alternative A of the 2023 EIS is the only acceptable alternative.
