

## **RICHLAND ROD AND GUN CLUB**

### **QUALITY TRIP RULES**

- Only RR&GC members with dues current and paid through March 31 of the year following the drawing are eligible to purchase raffle entry chance numbers.
- Entrants must be 18 years of age or older at the time of the drawing to purchase a raffle entry chance.
- Entry chance numbers are \$25 each. The amount to be paid to the winner will be a minimum of \$2000. The winner will also receive 50% of drawing proceeds above \$2,000 to a maximum payout of \$4000.
- A minimum of 60 raffle numbers must be sold to validate the drawing, otherwise all receipts will be refunded. A receipt will be issued for each raffle number purchased. No more than 4 raffle chances may be purchased by any individual member. Family memberships may purchase up to 8 chances in total but no more than 4 chances per person.
- A free entry chance in the raffle will be offered to any member who 1) purchases an entry chance in the drawing, and 2) accumulates 20 or more hours of volunteer work on club sponsored projects during the calendar year preceding the drawing. A second free chance will be offered if the individual purchases 2 or more entry chances and accumulates 40 or more hours of volunteer work as described in the preceding sentence. No member may be awarded more than two free entry chances in the drawing.
- The drawing will be held as the last event of the annual RR&GC Wild Game Dinner. The winner does not need to be present to win.
- The winner will select a partner who must have also participated in the drawing.
- An alternate winning number will also be drawn in the event the winner cannot take the approved trip in accordance with these rules.
- A written proposal must be submitted **and** an oral presentation made by the winner or the winner's partner to the RR&GC Board of Directors (BOD) not later than the May BOD meeting for approval. The proposal and presentation shall identify planned destination, purpose, cost, and dates of travel.
- The winner must have confirmation of key trip logistics (e.g. Guide services, airline tickets, lodging, etc.) by the June BOD meeting and the trip completed before December 31 of the current year. If the trip cannot be confirmed prior to the

August BOD meeting the winner shall forfeit the trip and the trip will be awarded to the alternate winning ticket holder.

- The winner shall notify the RR&GC President immediately in the event that the trip cannot be taken in accordance with these rules or the approved proposal. In this case the President will notify the alternate winner.
- The alternate winning ticket holder or the partner will present a written copy of the proposed trip with a verbal presentation to the RR&GC Board of Directors no later than the September Board meeting for approval.
- The alternate winner must have confirmation of key trip logistics (e.g. Guide services, airline tickets, lodging, etc.) by October 1 and the trip taken before March 31 of the following year.
- Quality trip funds will be allotted as reimbursements after the winner has paid for portions of the trip. For example, reimbursement for booking fees, airline tickets, etc. Note that a check for reimbursement will not be provided to the winner prior to incurring costs. The maximum amount reimbursed will be half the prize amount after the winner has incurred the initial trip costs. The balance will be paid upon completion of the reporting requirements.
- The winner will present a program describing their Quality Trip at a General Meeting of the membership in either February or March following the trip. Presentation date for an alternate winner will be later based on travel dates.
- The winner (or alternate) will provide a written summary of the completed trip, including logistical details such as travel distances and costs, lodging details and expenses, guide expenses and license costs, name and addresses of lodging and guides, photos and other details. The report will be published on the Club's website/Face Book page. (Examples of Quality Trip reports can be found on the Club's website.)
- The winner and alternate will sign and date a copy of these rules as an acknowledgement of understanding of the rules.
- The RR&GC President will inform the winner or alternate winner of the trip approval by the Board of Directors.
- The RR&GC Board of Directors may, if requested or by its own consideration, modify these rules for special circumstances.
